This is in reference to the current amendment made in the **E-Invoicing process related to GST**. **On 1 October 2020**, the government introduced e-invoicing for registered persons whose aggregate turnover exceeds **INR 500 crore** for reporting of **B2B invoices into the GST system**. Furthermore, this was also extended to companies with turnover exceeding **INR 10 crore from 1 October 2022 (vide Notification No. 17/2022 – Central Tax, dated 1 August 2022)**. Hence, many businesses would be entering this system for the first time and might face difficulties to adhere to the compliances.

- Enter your name, meeting ID, password & click on Join Meeting.
- When Prompted Choose “Join with Video”.
- Choose call via device audio & you will be connected to the meeting.

Important Note:

- **We have disabled telephone dial in options for security reasons.**
- **We recommend organizer to lock Meeting room after Meeting start & required participants joined.**
- **Zoom has made mandate that all attendees need to have latest version of Zoom app 5.0 Or higher version to join meeting. Latest version of Zoom app can be downloaded from “ <https://zoom.us/download> “ & respective android or apple store for mobile app.**
- To avoid Audio & video freezing, please use the best connectivity of good bandwidth.
- Requesting you to Please close the meeting on time so that other Consecutive meeting booked will not be affected.
- Always it's advisable to Mute your Laptop/ VC MIC if you are not speaking, Un-mute it only when required.
- Place your mobile phones in silent mode & do not place mobile phones near VC Microphone or Laptop microphone to avoid unnecessary noise getting induced.
- If you are connecting to meeting through a “**Computer**” with an external Speaker connected to it, make sure that you do not place the speakers close to Microphone of your laptop, which may result in echoing.
